Over the course of several months, we used group surveys, discussion, and votes at our meetings to identify a set of specific legislative goals that we want to see accomplished to improve the lives of our neighbors, our families, and ourselves. End gerrymandering by drawing congressional districts via nonpartisan institutions.

Further comments: Gerrymandering is a massive detriment to democracy at both the state and federal level. Obviously non-partisan districts would have to comply with the Voting Rights Act, which must also be taken into account. I will be watching the upcoming Supreme Court case of Gill v Whitford from Wisconsin to see if the courts will have a better solution than what state legislatures have individually proposed.

Automatically register voters.

Further comments: I would enthusiastically endorse automatic voter registration for all qualified citizens as long as safeguards are in place establish and easily check for duplicates and residency without violating privacy and ensuring digital security.

This seems like an easy issue, but it begins to get tricky when you consider that each town is responsible for keeping and maintaining records. This would likely be solved by a single statewide or even national database, and that creates massive privacy and data security concerns from hacking and political operatives. The recent request from the Trump Administration for all voter information from the states only heightens my concerns.

End the biased disenfranchisement of felons.

End monetary bail.

Further comments: While low risk, low income folks definitely should be allowed out of jail while awaiting trial, I am not sure it is appropriate to eliminate bail for flight risk individuals who can afford bail if that is what it takes to keep them from fleeing while awaiting trial. I would like to see data on how New Jersey's experiment with risk matrices instead of bail is going before eliminating bail in Massachusetts.

Make net neutrality the law and regulate internet service providers as utilities.

Further comments: The monopolies by internet service providers that have to potential to choke the flow of information based upon financial incentive is extremely troubling.

Internet access in 2017 should be treated like rural electrification in the early 20th century. Everybody should have access to it and internet providers should be required by law to treat rural and sparsely populated areas the same way that they treat high density regions.

Prevent internet service providers from selling your private information.
